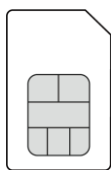
Read the following topics and perform the procedures in the correct order. Incorrect installation may cause damage to the product.

II-1. SIM Card Installation

Gently insert the standard SIM card(s) into the SIM card slot(s).

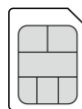

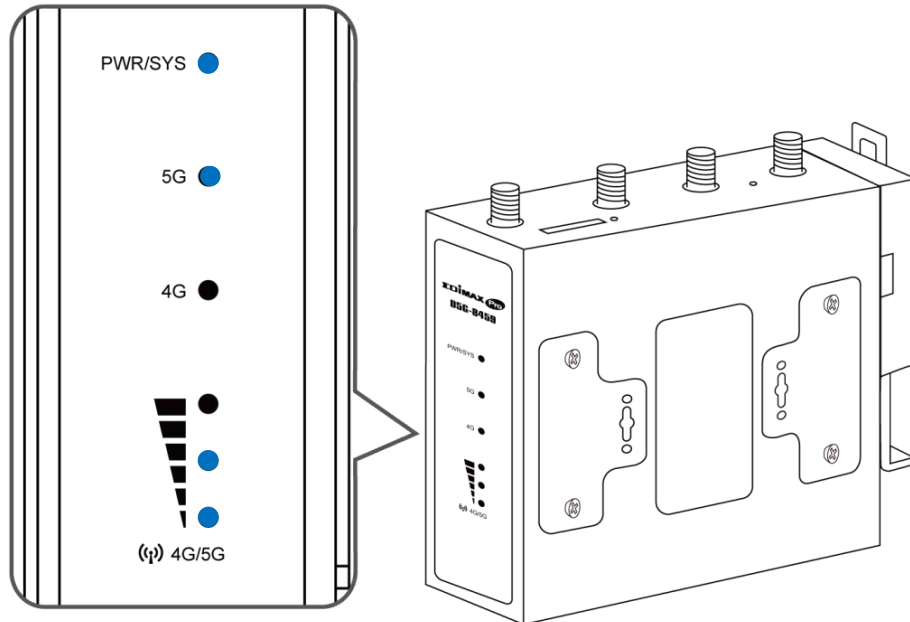


Note:

2. The 5G or 4G Router needs to be restarted. Otherwise the Internet connection can't be established.
3. Please make sure PIN code of SIM is disabled before inserting the SIM to the 5G or 4G router.

II-2. Power on the Router

Connect the power adapter to the product's power port and then to the wall outlet.



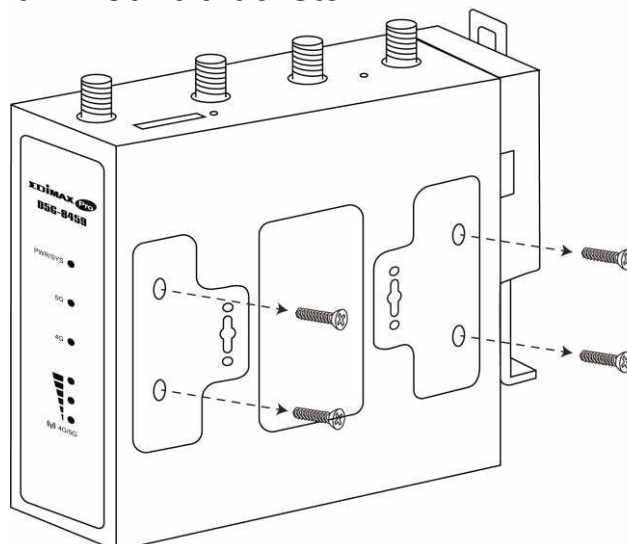
Note:

2. Make sure the “5G” or “4G” LED is ON (Blue).

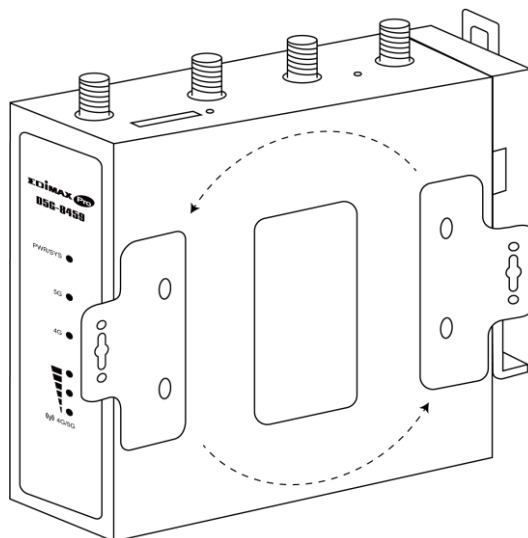
II-3. Mounting the Router

II-3-1. Wall-mount

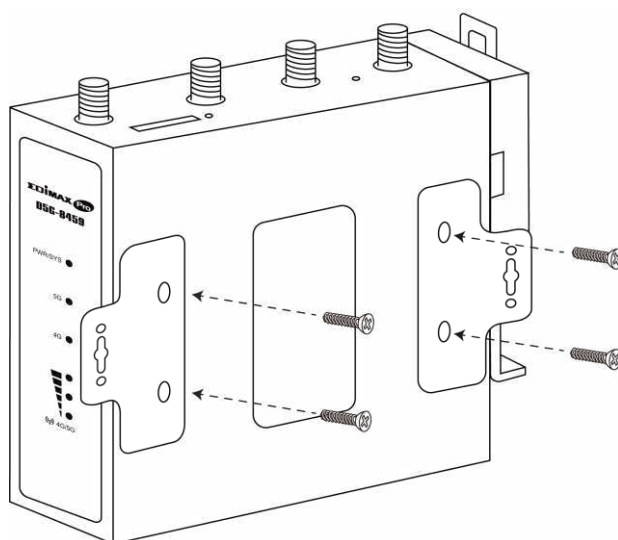
Step 1: Unscrew the wall-mount brackets.



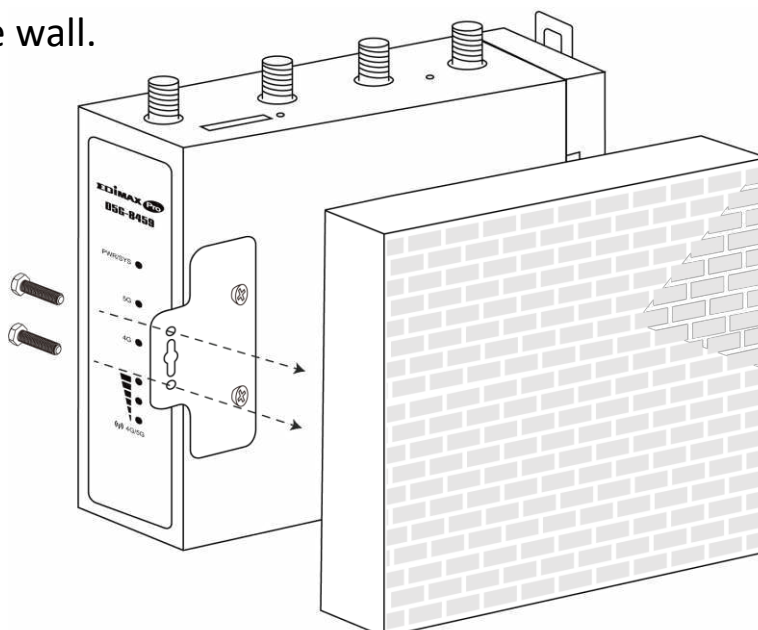
Step 2: Exchange the position of the brackets.



Step 3: Screw back the wall-mount brackets.

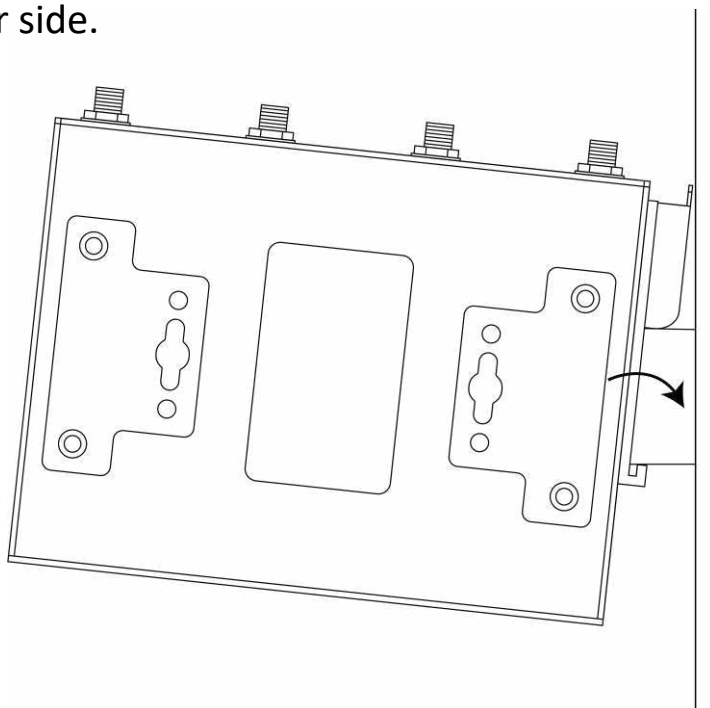


Step 4: Secure to the wall.

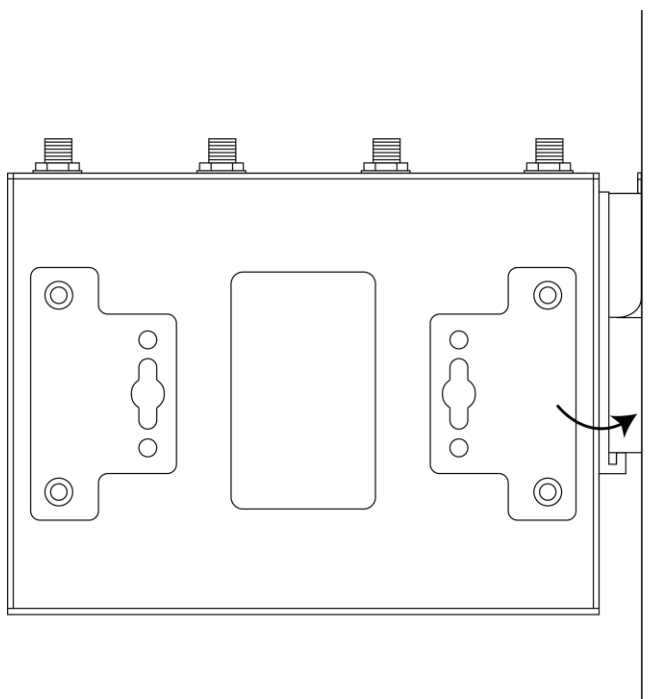


II-3-2. DIN Rail mount

Step 1: Insert the upper end of the DIN-Rail mounting bracket into the Din-Rail track from its upper side.



Step 2: Push the bottom of the DIN-Rail mounting bracket into the track.

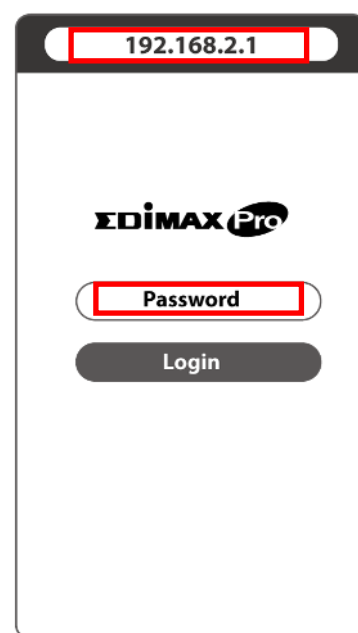

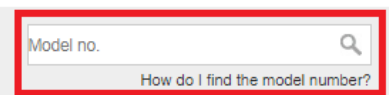
